2.3 Fixed Assets

Gain / (loss) on disposal of fixed assets, if any are charged against current year's revenue.

2.4 Current Assets

Current assets are stated at cost.

2.5 Expenditure

Expenditure is recognized on accrual basis.

2.6 Foreign Currency Transactions

Transactions in foreign currency, if any, are converted into Pak Rupees at the rates prevailing at the date of transaction.
