1. Fundraising Strategy for Ramzan (Priority Item)

- **Faces of GIKI Campaign** (*VP Marketing / Office Manager*)
A daily visibility campaign will be launched with **two posts per day till the end of Ramzan**, highlighting respected alumni, contributors, and supporters as the “Faces of GIKI” to build trust and fundraising momentum.
- **Donors’ Video Clips**
Short video messages from donors and influential alumni will be recorded and shared to encourage others through personal endorsement.
 - **The President** to send **individual video + text messages** to donors and alumni within his personal contacts.
 - Other EC members to follow the same approach to maximize outreach and impact.
- **Beneficiaries’ Statements (Impact Stories)** (*Office Manager*)
Anonymous written or video statements from beneficiaries will be shared, highlighting **the impact of support on their lives**, while maintaining strict privacy (no names, limited identifiers).
 - Office Manager to share a draft message in the EC; once approved, it will be sent to beneficiaries.
- **WhatsApp Reminders** (*Office Manager*)
Fundraising reminders and related content will be shared **every weekend** on WhatsApp groups, avoiding excessive formal announcements.

- Office Manager to share draft messages in the EC; once approved, messages will be circulated weekly and posted as announcements **twice during Ramzan**.
 - **Interviewers' Video Messages** (*Treasurer / VP Marketing*)
Alumni who participated as interviewers and were emotionally moved by the process will be encouraged to record short video messages in support of the campaign.
 - **Audience Beyond GIKI Alumni**
Fundraising messaging will explicitly encourage sharing with **friends, family, and non-GIKI contacts**, expanding outreach beyond the alumni network.
 - **Revision of Notification / Donation Form**
The current notification/donation form will be revised, as it is **overly GIKI-specific**; fields and language will be made more inclusive for non-GIKI contributors.
 - **Batch Coordinators Activation**
Each batch will have an active coordinator responsible for outreach, engagement, and fundraising within their batch, with defined targets and reporting.
 - Clear **quota-based fundraising targets** to be set for each batch.
 - Coordinators to mobilize batch mates, friends, and family.
 - Office Manager to arrange a **30-minute coordinators' meeting** with the EC next weekend.

2. Appointment of a Global Coordinator

- Mr. **Soban Jalil** was proposed as a potential Global Coordinator.
 - Office Manager to arrange a meeting with Mr. Soban Jalil and the EC next weekend.
 - The Global Coordinator will be tasked with activating and engaging global coordinators to strengthen alumni engagement worldwide.

3. GIKlan Support Fund

- Proposal to include the GIKlan Support Fund in the GIKIAA constitution, focused **exclusively on medical support for GIKlans**.
 - Objective: maximize collections to support **financially underprivileged GIKlans only**.
 - Concept tagline proposed: **"For GIKlans, By GIKlans."**

4. UBL Portal

- UBL portal documentation has been submitted.
 - Biometric verification is pending; the Office Manager will coordinate with UBL to arrange the process on **Tuesday**.

5. GIKIAA Audit (2024 & 2025)

- Most audit documentation has been completed; a few items remain pending.
 - **Gen. Secretary** will share the pending documents with the **President** and **Treasurer** for signatures and subsequent submission.

6. GIKIAA Representation on Governing Council / Board of Studies

- Proposal to actively nominate high-achieving alumni for:
 - Board of Studies
 - Academic advisory roles
 - The process will proceed via a **selection mechanism**, without a constitutional amendment at this stage.
 - The matter will be revisited if changes occur in the GIKI constitution.

7. Communication & Visibility

- A newsletter will be issued during Ramzan highlighting:

 - Objective: enhance trust, visibility, and momentum for fundraising efforts.

8. General Body Members (*Gen. Secretary*)

- Currently, signatures from **25 General Body members** are required for any constitutional amendment.
 - **Gen. Secretary** to discuss the matter with Mr. Imran and formalize a mechanism to streamline the process for current and future ECs.

9. Iftar Event (*Treasurer / VP Marketing*)

- An Iftar event will be arranged during the **first Ashra of Ramzan**.
- Participation will be ticket-based and open to spouses.
